### **HEALTH AND SAFETY FOLLOWING PANDEMIC**

*Mark Morris moved,  
Lara Morris seconded:*

Conference commends those employers who have worked with the Union to ensure that their employees are as safe as possible in the workplace.

Conference however, remains concerned that the Welsh Government, Local Authorities and Schools have paid little notice of existing Health and Safety Regulations.

Conference believes that schools should have had robust risk assessments in place before the pandemic and that these should have been consulted upon with Union representatives.

Conference calls upon the National Executive to:

- (i) lobïo Llywodraeth Cymru ac Awdurdodau Lleol i sefydlu Partneriaeth Gymdeithasol ystyrion gyda'r Undebau Gweithlu Addysg.
- (ii) lobïo Llywodraeth Cymru i gryfhau Canllawiau Gweithredol Iechyd a Diogelwch mewn ysgolion a sicrhau bod asiantaethau gorfodaeth yn cael eu defnyddio'n briodol, a,
- (iii) lobïo i gynyddu buddsoddiad mewn gwasanaethau cyhoeddus i gefnogi'r holl fesurau iechyd a diogelwch angenrheidiol yn well;
- (iv) gefnogi aelodau lle nad yw deddfwriaeth Iechyd a Diogelwch yn cael ei dilyn, a
- (v) darparu hyfforddiant i weithredwyr lle y galluogi i ddatblygu polisiau a gweithdrefnau Iechyd a Diogelwch yn y gweithle sy'n addas at y diben.

- (i) wedi ei ddylunio ar y cyd ag 'Athrawon Arweiniol' a enwebwyd gan gonsortia yn hytrach nag Athrawon Dosbarth;
- (ii) bod maint yr asesiad athrawon wedi cynyddu llwyth gwaith athrawon; a
- (iii) yn diffinio gofynion mympwyol ar gyfer meddalwedd ddrud sydd, hyd yn oed gyda chymhorthdal Llywodraeth Cymru, yn atal mynediad i'r cymhwyster hwn mewn ysgolion tlawd.

- (iii) lobby to increase investment in public services to better support all necessary health and safety measures
- (iv) support members where Health and Safety legislation isn't being followed, and
- (v) provide training for lay activists to enable them to develop workplace Health and Safety policies and procedures that are fit for purpose.

### **FAIRER FUNDING OF EDUCATION IN WALES**

Conference calls upon the National Executive to lobby the Welsh Government for a fairer mechanism for the funding schools across local authorities in Wales.

### **DEVELOPMENT OF QUALIFICATIONS**

*Craig Jenkins moved,*

*Jemma Paull seconded:*

Conference notes the recent development of a qualification in Digital Technology and that Qualifications Wales produced approval criteria for the qualification, such that the qualification:

- (i) was designed in conjunction with consortia-nominated 'Lead Teachers' rather than Classroom Teachers;
- (ii) the volume of teacher assessment increased the workload for teachers; and
- (iii) defines arbitrary requirements for expensive software that, even with Welsh Government subsidy, bars access to the qualification in cash-strapped schools.

Conference calls upon the National Executive to lobby Qualification Wales so that, when developing future qualifications:

- a) there is meaningful engagement with the profession;
- b) that Workload Impact Assessments are always carried out; and
- c) they are accessible to all learners.

### **ONLINE EDUCATION**

Mae'r Gynhadledd yn nodi'r defnydd cynyddol o wersi ffrydio byw ac addysgu ar-lein. Mae'r Gynhadledd yn galw ar y Pwyllgor Gwaith i weithio gyda rhanddeiliaid perthnasol i:

- (i) gytuno ar bolisi cenedlaethol ar gyfer defnydd diogel a chyfreithiol o ffrydio byw ac addysgu ar-lein;
- (ii) sicrhau bod gan athrawon yr amser, hyfforddiant ac adnoddau i'w cefnogi i ddatblygu adnoddau dysgu sy'n bodloni'r gofynion addysgu newydd hyn, gan gynnwys sylw ar adnoddau i ddisgyblion ag anghenion dysgu ychwanegol; a
- (iii) gwella caledwedd cyfrifiadurol, meddalwedd a darpariaeth rhyngwyd i roi isafswm safonol o fynediad i adnoddau ar-lein i bob disgybl.

### **RHEOLAETH LEOL AR YSGOLION**

Mae'r gynhadledd yn nodi bod Rheolaeth Leol Ysgolion wedi'i chyflwyno ym 1988 ar adeg cyn datganoli pan oedd yr athroniaeth wleidyddol ar addysg yn gwbl groes i werthoedd Cymru fodern.

Mae'r Gynhadledd yn nodi ymhellach bod Cyrff Llywodraethu wedi'u heithrio o Fil Partneriaeth Gymdeithasol Llywodraeth Cymru.

Cred y Gynhadledd fod LMS ynghyd ag eithrio Cyrff Llywodraethu o'r Bil yn gadael gweithwyr addysg yn agored i ragfarn a gwahaniaethu y byddai gweithwyr eraill yn cael eu hamddiffyn yn eu herbyn trwy bartneriaeth gymdeithasol.

Mae'r Gynhadledd yn galw ar y Pwyllgor Gwaith i:

- (i) lobio i gynnwys Cyrff Llywodraethu yn y Mesur Partneriaeth Gymdeithasol, ac
- (ii) ymgyrchu i roi diwedd ar LMS yng Nghymru



Conference notes the increasing use of live streaming lessons and online teaching.

Conference calls on the National Executive to work with relevant stakeholders to:

- (i) agree a national policy for the safe and legal use of live streaming and on-line teaching;
- (ii) ensure teachers have the time, training and resources to support them in developing learning resources to meet these new teaching requirements, to include a focus on resources for pupils with additional learning needs; and
- (iii) to improve the computer hardware, software and Internet provision to give all pupils a minimum standard of access to online resources.

### **TEACHERS' MENTAL HEALTH**

*Glynis Meredydd seconded:*

Conference believes there is a link between the abuse of teachers and the decline in their mental health.

Conference calls on the National Executive to work with relevant stakeholders to:

- (i) develop strategies to deal with verbal abuse directed towards school staff by pupils; and
- (ii) agree a national policy to provide dedicated mental health professionals available to support school staff.

The motion was **CARRIED**.

## **THIRD PUBLIC SESSION**

**1545h – 1725h**

### **LOCAL MANAGEMENT OF SCHOOLS**

*Angela Butler moved,*

*Annwyn Lewis seconded:*

Conference notes that Local Management of Schools (LMS) was introduced in 1988 at a time before devolution when the political philosophy relating to education was diametrically opposed to the values of modern Wales.

Conference further notes that Governing Bodies have been excluded from the Welsh Government Social Partnership Bill.

Conference believes that LMS and the exclusion of Governing Bodies from the Bill leaves education workers vulnerable to prejudice and discrimination that other workers would be protected against through social partnership.

Conference calls upon the National Executive to:

- (i) lobby for the inclusion of Governing Bodies in the Social Partnership Bill, and
- (ii) campaign for an end to LMS in Wales

Mae'r Gynhadledd yn nodi ymhellach bod ysgolion uwchradd bellach yn canolbwyntio ar gyflawni Cymwysterau ac yn parhau i fethu â blaenoriaethu'r Cwricwlwm Newydd.

Cred y Gynhadledd fod y Cwricwlwm Newydd yn ddiffygiol a bod angen ei ddatblygu'n helaeth ar lefel ysgol i'w wneud yn addas.

Mae'r gynhadledd yn galw ar y Pwyllgor Gwaith i:

### **THE NEW CURRICULUM**

Conference notes that last year has been focussed upon responding to the Covid-19 pandemic and therefore little time has been given to developing the new curriculum.

Conference further notes that secondary schools are now concentrating on qualifications and are still unable to prioritise the new curriculum.

Conference believes that the new curriculum is flawed and needs extensive development at a school level to make it fit for purpose.

Conference calls upon the National Executive to:

- (i) work with other stakeholders to build a campaign to postpone the implementation of the new curriculum for at least one year, and
- (ii) lobby the Welsh Government to amend the new curriculum so that it better reflects the values of modern Wales

### **THE EDUCATION WORKFORCE COUNCIL**

Conference believes that the Education Workforce Council continues to wield great power and influence on education in Wales.

Conference notes that it does this whilst being unaccountable to those who pay for it

Conference therefore calls upon the National Executive to campaign for the EWC to come under the responsibility of the Public Service Ombudsman to ensure that it is accountable to the people of Wales

Conference applauds Estyn for suspending Inspections during the Covid 19 Pandemic. Conference however, is concerned that 'pseudo' inspections have taken place where school leaders have invited Estyn in with the mistaken belief that this would lead to them being removed from the Special Measures category

Conference is further concerned that Estyn refuses to take into consideration the evidence of the outstanding work done by schools during the pandemic and is still requiring school visits to make inspection judgements.

Conference calls upon the National Executive to lobby the Welsh Government to reform Estyn to ensure that accountability in education in Wales is fit for the changes that have been made by the pandemic and will be made by the new curriculum.
